5. Publicity & Materials: Any publicity, study or assessment material bearing the name or emblem of the Government of Assam can not be used.
6. Data-Protection & Child-Safety: Collection and use of student data must comply with prevailing data-protection and child-safeguarding norms; no data shall be shared with third parties.
7. Reporting: A consolidated report on participation, results and feedback must be submitted to this office within thirty (30) days of the grand finale by the organisation.
8. Compliance: The Directorate reserves the right to withdraw this permission at any stage in case of any deviation from the above conditions or upon receipt of adverse reports.
