
The Competent Authority has granted permission for the year 2025-26 with the following terms & conditions:

1. No data of the students/parents address, contact numbers & findings of the project will be shared in the light of the privacy concern of the parents & students.
2. The schools working should not be disturbed. The safety & security of the students should be ensured.
3. **Financial aid will not be provided by the Directorate of Education, School (or) Student to the concerned NGO/Organization or to any person.**
4. Privacy of students/parents should not be affected in the process of project.
5. Material will not show any kind of advertisement, i.e., name, sign, logo, sponsorship & material should not be distributed by any Celebrity.
6. The recognition of the NGO/Organization should be registered & valid by the Competent Authority. Further it is the responsibility of the Head of the School (HoS) who should be satisfied & convinced by the NGO/Organization before the commencement of the subject.
7. The finding of the project should be shared with the Directorate of Education & not to be published in any media (Print/Electronic/Social).
8. There shall be no uploading of the images/pictures/videos of the students on social media pages except with the prior written permission of the Director (Education).
9. The Organization has to ensure that no damages occur while conducting the programme. It will be the sole responsibility of the Organization & it should be rectified to the entire satisfaction of the HoS, if there is any damage.
10. The permission is purely provisional & liable to be withdrawn at any time, if it is found to be against the national interest or causes any type of obstruction in the functioning of DoE as well as violation of these terms & conditions.
11. List of project team & their Bio-Data will be shared with the HoS prior to project.
12. The DoE will indemnify against any legal/financial liability/litigation that may arise out of the project process or its findings.
13. The HoSs to ensure that these programmes are run under the strict supervision of the designated teachers.
14. The completion report of the project should be submitted to concerned Districts & NGO branch.

Thus, the HoSs of all Government schools are directed to allow for the year 2025-26, the representative of Satyug Darshan Trust/Dhyan Kaksh (NGO), i.e., (Mrs. Anupama Talwar, Mob. 7087467777), for the same.
